The ACI FX Global Code Certificate

ACI is an association of financial market practitioners globally, with over 9,000 individual members across 63 National Associations.

Published on 25 May 2017 by the Bank for International Settlements Foreign Exchange Working Group, the FX Global Code (FXGC) provides a common set of principles and guidelines to promote the integrity and effective functioning of the wholesale foreign exchange market.

The ACI FX Global Code Certificate offers formal testing and qualification of an individual's comprehensive understanding of the 6 themes and 55 principles set out in the Code, testing practical application of aligned best market practices with real 'use case' scenarios.

The Certificate is an excellent first step to demonstrating adherence to the new Global Code to relevant competent authorities and a potential differentiator in respect of 'Code compliance' and career development.

This programme is designed for all Market Participants defined by the Global Code, including:

- Financial market participants across buy side, sell side and intermediary institutions
- Regulators and central banks
- Middle office and operations personnel
- Compliance and risk officers

Exam Syllabus

The exam comprises 40 multiple-choice questions with a 75% pass mark and lasts one hour. It is taken on a computer at a testing centre in most major cities.

The break-down of the exam questions per topic is as follows:

Dates

Webinars

- 45-minute presentations by the Facilitator with regular opportunities for the Learners to ask questions.
- Each presentation is followed by a 15-minute break for the Learners to refresh.
- There are topic tests and preparatory reading to be completed by the Learners between sessions.

Online Self-Test Question Database

The candidates are provided with access to a database of 150 self-test questions, covering all of the themes and principles of the Code.

The questions have been designed by our expert faculty to closely reflect the nature and level of complexity of the questions in the real exam. They also include a number of 'sample questions' prepared by ACI Education to assist candidates in preparing for the exam.

Access is available 24/7 and a candidate's score, as well as references to the relevant Principles of the Code, are immediately available upon completion.

E-mail Help Facility

Candidates are encouraged to contact our team of expert facilitators via e-mail concerning any queries they may have with the syllabus. Answers are guaranteed to such queries within 24 hours from Monday to Friday and are usually communicated a lot sooner.

Exam Registration

The exam is written at a local testing centre, located in most major cities.

Fees
